Boundary – The boundary for the preparation of Northland Document Solutions Limited’s greenhouse gas (GHG) inventory is for one site. All business activities have been included.

Consolidation approach – Operational control.

Base year – 01/04/2009 to 31/03/2010

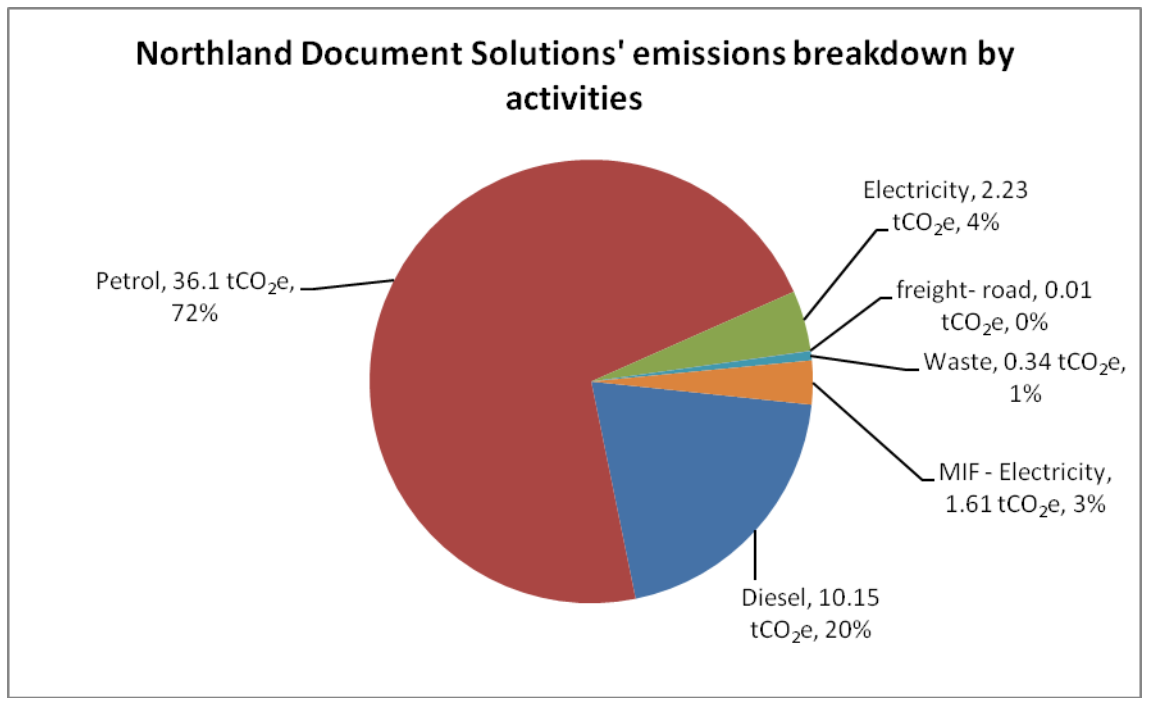
Measurement period – 01/04/2009 to 31/03/2010 (projected)

GHG emissions source inclusions – The diagram below shows the operational GHG emissions for Northland Document Solutions Limited by emissions source. Total emissions for this period were **50.42** tonnes carbon dioxide equivalents (tCO₂e). The breakdown for the total emissions by scope was Scope 1: 46.25 tCO₂e; Scope 2: 2.23 tCO₂e and Scope 3: 1.95 tCO₂e.

GHG emissions source exclusions – freight under 2kg was excluded from this inventory based on the de minimis rule.

GHG emissions reduction commitments – HBDT has developed the following emissions management goals:

1. Reduce energy consumption by turning off lights and copiers at end of the day (April 2010)
2. Reduce courier use by incorporating toner deliveries into technicians' service roles (April 2010)
3. Reduce the amount of waste sent to landfills by recycling polystyrene (April 2010)
